## Conditions:

1. Current EFA rules (effective 1<sup>st</sup> January 2004) and FEI rules (21<sup>st</sup> Edition 2003) apply.
2. Entry in official competitions is restricted to horses registered with, and whose owners and riders are members of the EFA. A maximum of 3 horses per rider permitted.
3. One rider only per horse. Organisers must be notified of any change of rider before the event starts.
4. No refunds after close of entries unless substantiated with medical and/or veterinary certification within 7 days of the completion of the event.
5. Administration fee MUST be paid by all riders otherwise entry will not be accepted.
6. Objections: attention is drawn to the current Australian Dressage Rules and official procedure for dressage competitions.
7. Only the owner/rider of a horse taking part in the competition may lodge a protest. This must be in writing to the Secretary of the event with a \$100 deposit not later than 30 minutes after the happening that gave rise to the protest or in the case of the qualification of the competitor, not later than 30 minutes before the start of the class.
8. The committee reserves the right to alter, amend or cancel any section of the programme or to limit the number of entries if nominations are excessive.
9. The committee reserves the right to accept or reject entries.
10. In the event of illness or accident to rider prior to the commencement of the event, a substitute rider may be arranged, however a substitute horse cannot be placed instead of the nominated horse.
11. Test result sheets and ribbons MUST be collected at the competition or forfeited. Toowoomba Dressage Inc will not be responsible for mailing these unless a self addressed, pre-paid business size envelope or \$2 for same is provided.
12. Prizemoney will be forwarded to winners in the form of a cheque after the event. Prizes of goods or vouchers to the relevant value will, where possible, be presented on the day. The OC reserves the right to reduce prizemoney to 1<sup>st</sup> place only where competitions have fewer than 5 starters.
13. In the event that any competition receives more than 35 entries, the OC reserves the right to divided the competition into two or more divisions or a reserve list created on a first in basis.
14. Dogs on the grounds are not a preferred option. If dogs are present, they MUST be leashed and under control of the owner/handler at all times. The owner of any dog on the ground accepts the responsibility of the consequent action caused by the dog.
